In consideration of the mutual and respective covenants and agreements hereinafter contained the parties hereto hereby declare and agree as follows:

- 1. The term of the contract is for the duration of the player's participation in Interdek Hockey inc.

- 4. The league will not be responsible for any cost or any transport situation for injuries or any other situation that can occur. The player acknowledges that the league advises wearing protective equipment (including a helmet), and refuses to do so on his own accord.
- 5. The player promises and agrees to assume full responsibility concerning all accidents, injuries, thefts or any other situations that may occur to him on league premises.
- 6. The player agrees to comply with the rules and regulations of the league and any rule that may hereafter be adopted as given to team captains.
- 7. The player agrees to comply with all rules pertaining to the facility hosting any Interdek Hockey activity.
- 8. The player acknowledges that the league shall have the right to discipline, suspend the player for any period or indefinitely, or expel the player from the league. The player agrees that no sum of money will be reimbursed to him.
- 9. This agreement contains the entire agreement between the parties and there are no oral or written indictments, promises, or agreements except as contained herein.
